

Party: I and Party: II agree by this MoU to work hereafter for the greater interest of both the Organizations in respect of following points:


1. Both the parties agreed for holding of workshop, seminar, job training programme, IT skill development training, etc. for greater interest of the student community of the college.

4. The validity of this MoU will remain for a period of 5 years, w.e.f. 22nd April, 2021.



**MEMORANDUM OF UNDERSTANDING

Dr. B.K.B. College, Puranigudam, Nagaon, Assam, hereinafter referred to as "BKBC" and Nagaon District Karate Association (NDKA) (Under Unified Karate Association of Assam (UKAA)), Nagaon, Assam, hereinafter referred to as "NDKA", hereinafter individually referred to as "the Party" and jointly referred to as "the Parties".

Acknowledging that –

1. BKBC is a Degree level provincialized educational institution, having its address as Puranigudam, Nagaon, Assam – 782141
2. NDKA is an association, trains the youth of Assam in the field of Karate, having its address as Nagaon, Assam – 782001.

DESIRING to – Support the cooperation between the Parties in Extension Activities and Training Programmes,

PURSUANT to – the prevailing laws and regulations, policies and procedures that govern the educational institutes of Assam

HAVE REACHED the following understanding:

ARTICLE 1

OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MoU) is to cooperate in extension activities and training programmes in areas of mutual interests.

ARTICLE 2

SCOPE OF COOPERATION

The Parties agree to implement cooperation programmes including but not limited to:

- (a) Faculty Support under Institutional Linkage Programmes
- (b) Extension activity and training programmes support
- (c) Any other areas, like self defence as mutually agreed upon by the Parties

ARTICLE 3

LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in ARTICLE 2 at BKBC and NDKA.
2. Any changes to the location of the programmes shall be mutually agreed upon by the Parties.

ARTICLE 4

FINANCIAL ARRANGEMENT

2. Any specific project of joint interest will be detailed in a separate agreement, including financial and programme specific arrangements.

ARTICLE 5

INTELLECTUAL PROPERTY RIGHTS

1. Each Party shall protect, within its capacity and territory, intellectual property rights of the other Party in accordance with the laws and regulations in force in the state of Assam and the country of India.
2. In case of specific arrangement, programmes or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with the prevalent laws and regulations in the state of Assam and the country of India.

ARTICLE 6

AMENDMENT

1. This MoU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall form an integral part of this MoU.
2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

ARTICLE 7

ENTRY INTO FORCE, DURATION AND TERMINATION

1. This MoU shall enter into force on the date of signing.

2. This MoU shall remain in force for a period of five (05) years and may be extended for another period of five (05) years by mutual consent of the Parties.

3. Either Party may terminate this MoU at any time by given written notification to the other Party on its intention to terminate this MoU, six (06) months prior to the date of the termination.

4. The termination of this MoU shall not affect the completion of any programmes or projects in progress and not completed at the time of termination.



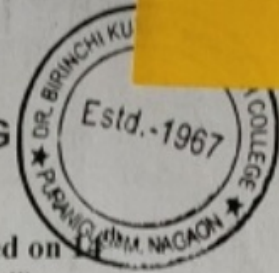

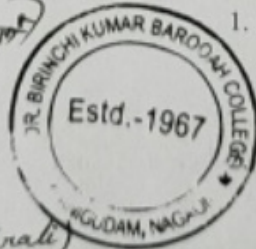
